2. Review of Agenda

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

4. Water Report and Informational Items

5. Public Participation

At this time, members of the public may address the Board on matters that are not on the agenda, which affect the operations of the District and are within the jurisdiction of the Board. The President may limit the time allowed for comment. (Members of the public may also address the Board on any matter on the agenda, when that item is brought up.)

6. George Souza Detachment

a. Negative Declaration

Following a public hearing, at which members of the public may make comments as to the potential environmental impacts of the proposed George Souza Detachment, the Board will be asked to adopt Resolution No. 17-02 to approve a negative declaration.

6. George Souza Detachment (Continued)

b. LAFCO Proceedings

The Board will be asked to adopt Resolution No. 17-03, to request LAFCO to initiate proceedings to detach approximately 2.8 acres from CCID, in the Southwest quarter of Section 5, T.8S., R.9E., M.D.B.&M., north of North Road and approximately one-quarter mile west of Highway 33, in the City of Gustine.

7. On-Farm Water Conservation Program

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

8. Water Policies for 2017

Staff and the Board will resume their review of existing District water policies, in particular with regard to water transfers for 2017. After the discussion, the Board may act to modify the rules governing pumping of private wells for water credits in other districts, and/or the rules governing fallowing of CCID land for water credit in other districts.

10. Monthly Financial Report

The Secretary will present figures through January 31 for water sales, revenues and expenses in comparison to the 2017 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected to be taken.

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.
