2. Review of Agenda

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

5. Public Participation

Members of the public may address the Board on matters that are not on the agenda, which affect the operations of the District and are within the jurisdiction of the Board. 6. On-Farm Water Conservation Projects

A number of on-farm conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be presented for final approval and funding. The Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the President and Secretary to execute the loan documents on behalf of the District.

8. Monthly Financial Report

The Secretary will present figures through May 31 for water sales, revenues and expenses in comparison to the 2013 budget, receivables, investments, and the reserve funds for water conservation loans and projects. No Board action is expected to be taken.

9. 2013 Water Supply

As a follow-up to the Special Meeting of June 21, staff will present information and data on water sales to date, cropping patterns and supply conditions for the balance of the 2013 water season, along with water resource management alternatives. Board action may be taken.

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.

11. Miscellaneous Business

12. Public Hearing - Proposition 218 Benefit Assessment Election (10:00 a.m.)

At about 10:00 a.m., the President will call to order a Public Hearing for the purpose of discussing, answering questions and accepting public input on the proposed implementation of a land-based assessment to help fund the annual costs of participation in the Westside Watershed Coalition. At the conclusion of the Public Hearing, anticipated to be approximately 11:00 a.m., CCID staff will open and tabulate the ballots that have been turned in by the deadline of 11:00 a.m. This process will take place in the lobby of the Main Office, and members of the public are entitled to observe.

If it has been determined that the majority of the ballots submitted in the Proposition 218 Election, weighted in proportion to their assessment liability, were in favor of the proposed Benefit Assessment, the Board will be asked to approve the implementation of an assessment of \$0.88 per gross acre for the 2013-2014 Fiscal Year for all in-District acreage that has membership in the Westside Watershed Coalition. If it is determined that the election failed, the Board will be asked to consider the future of the District's role in the Westside Watershed Coalition.
