David Hodgin, a member of the Executive Committee of the ACWA Joint Powers Insurance Authority, will present a refund check to the District resulting from good loss history in JPIA's self-insured programs. No Board action will be taken.

**8. Pumping of Private Wells for Water Credits in Federal Districts in 2016**

The Board will be asked to review and approve requests from one or more CCID landowners who wish to pump private wells for water credits for their own properties in neighboring Federal districts in 2016.

The Secretary will present figures through March 31 for water sales, revenues and expenses in comparison to the 2016 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected to be taken.
