**2. Review of Agenda**

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

**5. Public Participation**

At this time, members of the public may address the Board on matters that are not on the agenda, which affect the operations of the District and are within the jurisdiction of the Board. The President may limit the time allowed for comment. (Members of the public may also address the Board on any matter on the agenda, when that item is brought up.)

**6. OES/FEMA Update**

The District is expecting the notice to proceed with Phase 1 of the Hazard Mitigation Plan for Los Banos Creek, Orestimba Creek and Red Top soon. The notice will likely be received after the Board meeting and staff would like to begin the process for design and development as soon as possible. The Board will be asked to grant permission to staff to begin work and start a selection process for the engineering services once the notice to proceed is received.

7. **On-Farm Water Conservation Program**

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.
8. **Medical Insurance**

The District has received renewal rates for Calendar Year 2019 for the District's high deductible medical insurance. Staff is not proposing any changes to the plan elements and will present the new rates to the Board for approval. Board action will be requested.

10. **Monthly Financial Report**

The Secretary will present figures through August 31 for water sales, revenues and expenses in comparison to the 2018 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.
