5. Public Participation

6. On-Farm Water Conservation Program

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

7. **Transfer of Water to Triangle T Water District**

Staff will present a proposed agreement between the District and the Triangle T Water District to wheel Rio Bravo water to Triangle T Water District through the Red Top pipeline. Board action will be requested.
8. **Personnel – General Manager Selection**

The Personnel Policy Committee has reviewed the applications received for General Manager and will present their recommendation to the Board for the replacement of the General Manager. Board action will be requested.

10. **Monthly Financial Report**

The Secretary will present figures through June 30 for water sales, revenues and expenses in comparison to the 2019 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.
