1. Call to Order – Pledge of Allegiance

2. Review of Agenda

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

5. Public Participation

6. On-Farm Water Conservation Program

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

8. **Monthly Financial Report**

The Secretary will present figures through September 30 for water sales, revenues and expenses in comparison to the 2019 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

10. **Proposed 2020 Budget for Exchange Contractors**

The Executive Director will present a draft of the proposed 2020 budget for the Exchange Contractors. The Board will be asked to review the proposal and give President O'Banion direction as to how to vote at the Four Entities' next Board meeting, on November 1.
11. **Connley Clayton Agreement**

The District has been working extensively on an agreement with Connley Clayton to reduce subsidence near Sack Dam. The District is requesting that Connley Clayton eliminate the use of wells perforated below the Corcoran Clay. It is anticipated that a signed agreement will be ready to be presented to the Board for approval. Board action will be requested.
12. **Legal and Four-Entities Matters**

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.
13. **Miscellaneous Business**

At this time, Board members and staff may discuss matters that are not on the agenda which may affect operations of the District. No Board action is expected to be taken.
