**2. Review of Agenda**

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

**6. On-Farm Water Conservation Program**

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

**8. Monthly Financial Report**

The Secretary will present figures through June 30 for water sales, revenues and expenses in comparison to the 2020 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

Staff is recommending a change that will include the word spouse to the following District Policies:

- a. Rules Governing Pumping of Private Wells For Water Credits in Other Districts
- b. Rules Governing Fallowing of CCID Land for Water Credits in Other Districts

**10. Pumping of Private Wells for Water Credits in Federal Districts in 2020**

The Board will be asked to review and approve a new request from Gilardi Farms who wish to pump their private well(s?) for water credits on their own property in a neighboring Federal district in 2020.

**11. Mowry Bridge Agreements**

Staff have been working on two agreements for the Mowry Bridge replacement. The Board will be asked to take action on the following agreements:

- a. City of Mendota – for a construction and access easement through the District’s property.
- b. Bureau of Reclamation – for an access easement through the District’s property.

12. **Legal and Four-Entities Matters**

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.

13. **Miscellaneous Business**

At this time, Board members and staff may discuss matters that are not on the agenda which may affect operations of the District. No Board action is expected to be taken.
