1. **Call to Order – Pledge of Allegiance**
2. **Review of Agenda**

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

5. **Public Participation**

At this time, members of the public may address the Board on matters that are not on the agenda, which affect the operations of the District and are within the jurisdiction of the Board. 6. **On-Farm Water Conservation Program**

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

7. **Approval of August 2020 Warrants**

8. **Monthly Financial Report**

The Administrative Assistant will present figures through August 31 for water sales, revenues and expenses in comparison to the 2020 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

9. **Medical Insurance**

The District has received renewal rates for Calendar Year 2021 for the District's high deductible medical insurance plan. Staff is not proposing any changes to the plan elements and will present the new rates to the Board for approval. Board action will be requested.

10. **Proposed Underground Pipe Crossings in District's Right-of-Way**

Doug C. Brunner has requested permission to install an underground pipeline in the Santa Rita Ditch right-of-way. The proposed license agreement meets all District standards. The Board will be asked to approve the agreement and authorize the President and Assistant Secretary to execute the agreement on behalf of the District.

11. **Award of Proposal – Orestimba Creek Recharge Project**

Staff will present details of the recent proposals received for the Orestimba Creek Recharge Project. The Board will be asked to award the contract and authorize the Manager to execute the documents on behalf of the District.

12. **Legal and Four-Entities Matters**

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.

13. **Miscellaneous Business**

At this time, Board members and staff may discuss matters that are not on the agenda which may affect operations of the District. No Board action is expected to be taken.
