2. **Review of Agenda**

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

6. **On-Farm Water Conservation Program**

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.
7. **Approval of July 2021 Warrants**
8. **Monthly Financial Report**

The Administrative Assistant will present figures through July 31 for water sales, revenues and expenses in comparison to the 2021 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.
9. **Bay-Delta Water Quality and Regional Water Quality Control Board Report**

The Board will receive an update on the water quality issues.
10. **Petition and Maintenance Agreement – Dos Palos Drainage District**

The Board will review and consider executing a Petition and Maintenance agreement with Dos Palos Drainage District for the routine maintenance of the facilities and minor improvements. The Board will be asked to approve the agreement and authorize the President to execute the agreement on behalf of the District.
11. **Medical Insurance**

The District has received renewal rates for Calendar Year 2022 for the District’s high deductible medical insurance plan. Staff is not proposing any changes to the plan elements and will present the new rates to the Board for approval. Board action will be requested.
12. **Legal and Four-Entities Matters**

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.
13. **Miscellaneous Business**

At this time, Board members and staff may discuss matters that are not on the agenda which may affect operations of the District. No Board action is expected to be taken.
