6. **Director, Division No. 4**

Following the passing of Division 4 Director James O'Banion, the District has posted notice of the vacancy in accordance with State law. The remaining Board members have the authority to fill the position at this meeting, and will be asked to make the appointment after considering expressions of interest that have been received from qualified candidates by the deadline date of November 15, 2021.

8. **On-Farm Water Conservation Program**

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

9. **Approval of October 2021 Warrants**

10. **Monthly Financial Report**

The Administrative Assistant will present figures through October 31 for water sales, revenues and expenses in comparison to the 2021 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

11. **Resolution No. 21-17**

The Board will review and consider adoption of Resolution No. 21-17 acknowledging continued State of Emergency and authorizing remote meeting options.

12. **Proposed License Agreement in District's Right-of-Way**

Richard Davis has requested permission to install a driveway for residential use in the District's right-of-way known as Meredith Avenue Canal Reservation. The proposed license agreement meets all District standards. The Board will be asked to approve the agreement and authorize the President and Assistant Secretary to execute the agreement on behalf of the District.

13. **Proposed 2022 Water Resources Budget for Exchange Contractors**

The Executive Director will present the 2022 Water Resources budget.

The Board will be asked to review the proposals and give a CCID representative direction as to how to vote at the Four Entities' next Board meeting, on December 3.

14. **Proposed 2022 CCID Water Rates and Budget**

Staff will present the first draft of the proposed 2022 Water Rates and Budget, based on a Critical Year water supply in 2022, and will go over highlights of the proposals. The Board will review the water rates and budget proposal as presented under advisement for consideration at the next Board meeting. Specifically, the presentation will include these items:

- a. Proposed 2022 water rates and tier quantities based on a Critical Year water supply
- b. Proposed 2022 General District budget
- c. Anticipated revenues and expenditures for the CCID Water Conservation Projects Fund in 2022, with a ten-year cash flow projection for the Fund, from 2022 through 2031

15. **Legal and Four-Entities Matters**

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.
