10. **Monthly Financial Report**

The Administrative Assistant will present figures through November 30 for water sales, revenues and expenses in comparison to the 2021 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

At the previous meeting, staff presented the first draft of the proposed 2022 Water Rates and Budget, based on a Critical Year water supply in 2022. The Board will be asked to approve the water rate schedule and budget proposal as presented based on a Critical Year.

General Counsel, the Executive Director and the Manager will discuss with the Board current issues affecting the Exchange Contractors and CCID. Board action may be requested on any of these matters.
