6. Ingomar's Potable Water Generation

Ingomar representatives will provide a presentation relating to potable water generation and with a potential partnership with the District to provide water to local disadvantaged communities.

7. On-Farm Water Conservation Program

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

9. Monthly Financial Report

The Secretary will present figures through June 30 for water sales, revenues and expenses in comparison to the 2022 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

10. License Agreement – Russell Harris Farms

The Board will review and consider approving a license agreement with Russell Harris for an aboveground irrigation pipeline across the Poso Canal. The request meets District engineering standards and the proposed license agreement is in line with District legal and insurance requirements.
