2. Review of Agenda

The Board will consider corrections or additions to the agenda of items requiring immediate action that have come to the attention of the District following the posting of the agenda.

5. Public Participation

6. On-Farm Water Conservation Program

One or more conservation projects that have previously received preliminary approval from the Water Conservation Policy Committee will be described and the Board will be asked to approve incentive grants and/or loans for the projects, and to authorize the execution of the loan documents.

8. Monthly Financial Report

The Secretary will present figures through September 30 for water sales, revenues and expenses in comparison to the 2023 budget, receivables, investments, and reserve funds for water conservation loans and projects. No Board action is expected.

9. Del Puerto Canyon Reservoir - Project Participation Agreement

The Board will review and consider authorizing the project participation agreement with San Joaquin River Exchange Contractors Water Authority for the Del Puerto Canyon Reservoir Project.

10. License Agreement – Patrick Cerutti

The Board will review and consider approving a license agreement with Patrick Cerutti for an underground irrigation water pipeline within the District’s Main Canal right-of-way.

11. License Agreement – San Luis Wasteway

The Board will review and consider approving a license agreement with Santa Nella County Water District to construct an underground domestic and municipal water pipeline facility within the District’s Outside Canal right-of-way, for SNCWD well 3 discharges and San Luis Wasteway crossing.

12. License Agreement – Santa Nella County Water District Consolidation Project

The Board will review and consider approving a license agreement with Santa Nella County Water District to construct an underground water transmission pipeline within the District’s Main Canal and Outside Canal right-of-way, for SNCWD water quality improvement and Volta Consolidation Project.

13. Fiscal Year 2023 – Budget Amendment

The Board will review and consider authorizing additional funding to specific line items for the 2023 fiscal year budget.

14. Proposed 2024 Budget for Exchange Contractors

The Executive Director will present two proposed 2024 budgets. The Board will be asked to review the proposals and give a CCID representative direction as to how to vote at the Four Entities’ next Board meeting, on November 3.
